# **Delivery Policy**

ACG Consulting Ltd shall use reasonable endeavours to despatch goods by the date agreed with the customer, but does not accept liability for failure to deliver within the stated time where this is caused by circumstances beyond our reasonable control, such as delays caused by delivery companies or manufacturer lead times. If a delay is likely, we shall contact the customer and advise of the delay. Customers shall be entitled to cancel an order when advised of a delay if the revised delivery date is not acceptable.

If ACG Consulting Ltd is unable to deliver the goods within 14 days of the agreed delivery date, the Customer will, as its sole remedy, be entitled to cancel the order and require any monies paid to ACG Consulting Ltd in respect of that order to be refunded. In order to cancel, the Customer must send written notice of cancellation to ACG Consulting Ltd after the above date but before delivery of the goods or notification from ACG Consulting Ltd that the goods are ready for delivery.

ACG Consulting Ltd does not accept liability for shortages or damage to deliveries unless the Customer notifies ACG Consulting Ltd of the shortage or damage in writing within 48 hours of receipt of the delivery. Consumers should notify shortages or damage within a reasonable period of becoming aware.

Customers are required to be able to accept the goods when they are ready for delivery within Normal Working Hours.

Delivery is deemed to take place when the goods are delivered to the Customer's nominated address, whereupon the risks of loss, breakage and all damage and all other risks shall pass to the Customer.

Title in the goods does not pass to the Customer until payment is received in full by ACG Consulting Ltd.

If the Customer cannot accept delivery, ACG Consulting may at its option: (a) store and insure the goods at the Customer's expense and risk or (b) sell the goods at the best price reasonably obtainable and (after deducting reasonable storage insurance and selling costs) pay to the Customer any excess over the sale price or charge the Customer for any shortfall or (c) rearrange delivery provided that ACG Consulting Ltd may charge the Customer for the additional delivery costs incurred.

The Customer may request a Proof of Delivery, provided that this request is made in writing within 3 months of the date of delivery and ACG Consulting Ltd shall use reasonable endeavours to provide such proof. Thereafter, delivery shall be deemed to have been successfully completed.

Upon delivery of the goods, the Customer will be asked to sign a Proof of Delivery to acknowledge safe receipt. It is the responsibility of the Customer to ensure that the number of packages delivered corresponds with the number stated on the delivery note. Where a discrepancy occurs or where there is evident damage to the packaging, this should be noted on the Proof of Delivery. ACG Consulting Ltd shall not be liable for discrepancies or damage evident on delivery where the Customer accepts delivery and signs the Proof of Delivery without amendment.

### **Returns/Refunds/Cancellation policy**

You should let us know about any billing problems or discrepancies promptly after they first appear on your account statement.
